MANAGEMENT'S RESPONSIBILITY

The compliance with the requirements of (i) the Act and the Rules made thereunder (ii) the MCA Circulars and (iii) the Listing Regulations, 2015 relating to e-voting on the resolutions contained in the Postal Ballot Notice is the responsibility of the management of the company. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

SCRUTINIZER'S RESPONSIBILITY

My responsibility as Scrutinizer for the Postal Ballot process is limited to make a Scrutinizer's Report of the votes cast "in Favour" or "Against" on the resolutions as stated in the said notice, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited (hereinafter referred to as "CDSL"), the agency engaged by the Company to provide e-voting facilities for voting through electronic means.

I, hereby submit my report as under:

- In terms of Section 108 and Section 110 of the Companies Act, 2013 read with the Rules and the Listing Regulations, 2015, the Company had made arrangement with Central Depository Services (India) Limited for providing facility of voting through Remote Evoting to its members.
- 2. The Company sent Postal Ballot Notice, along with Explanatory Statement pursuant to Section 102 of the Act on Tuesday, September 16, 2025 by the electronic mode (e-mail) to those members whose email addresses were registered with the Company / Depository Participants, pursuant to the aforementioned MCA Circulars. A copy of said Postal Ballot Notice was published on the website of the Company and Central Depository Services (India) Limited.
- 3. Pursuant to MCA Circulars, physical ballots were not dispatched. Accordingly, the communication of the assent or dissent of the members had taken place through the Remote E-voting only.
- 4. As per sub-rule (3) of Rule 22 of the Rules and MCA Circulars, the Company published an advertisement on Wednesday, September 17, 2025 about the dispatch of Postal Ballot Notice in 'Financial Express' (English Newspaper) and 'Jansatta' (Hindi Newspaper-Delhi Edition).

- 5. The members of the Company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained for it by the Depositories (in case of shares held in dematerialized form) as on the cut-off date i.e. Monday, September 15, 2025 were entitled to avail Remote E-voting facility, in respect of resolutions as set out in the Postal Ballot Notice.
- 6. The voting through electronic remain commenced from Thursday, September 18, 2025, at 09:00 A.M. (IST) till Friday, October 17, 2025, at 05:00 P.M. (IST).
- 7. All votes cast through Remote E-voting during the above-mentioned period, were considered for scrutiny and at the end of Remote E-voting period, the Remote E-voting facility was blocked by Central Depository Services (India) Limited forthwith.
- 8. The votes were unblocked on 18th October 2025 in presence of two witnesses namely Ms. Jayshree Kanswal and Mr. Narender Singh who are not in employment of the Company.
